



REGULATION VASCELLERO DOG VILLAGE - EDITION 2023

1. Dogs of all sizes and breeds are admitted to the Vascellero. They must be provided of a health record, free of parasites and have all the vaccinations required by national legislation.
2. The presence of dogs must be reported at the time of booking.
3. At check-in, the microchip number will be registered and a special tag is issued, which must be prominently displayed on the dog's collar or harness for the entire duration of the stay.
4. A security deposit of € 200.00 per room must be paid in cash upon arrival.

The management reserves the right to withhold in the event of non-compliance with these regulations or in the event of damage to the room and its furnishings.

5. A form will be provided upon check-in detailing any damage to the room caused by previous 4-legged guests. If the guest notices any other damage due to the behavior of a dog, he is obliged to note it in the spaces provided on the form and send it to reception by 12:00 p.m. the day after arrival.

If you do not return this form, any further not reported damage found in the room will be billed at check-out.

6. For each room or house there is a maximum of 2 dogs, if large (over 20 kg), maximum 1.
7. In the Dog House it is possible to have a kennel so that your four-legged friend can rest and not climb on the beds (the temptation will be great, but we trust the correctness of the owners...). At the same time, it is also possible to collect two trays, a fence that can be attached to the porch (if any), and a mat under trays. A deposit of 20 euros is required to collect the equipment, which will be returned upon return before departure.
8. The cleaning of the rooms of the hotel formula guests takes place between 8:30 a.m. and 1:30 p.m. with disinfectants. It is the housekeeper's responsibility to arrange the timing directly with the owners so that the dogs are not left in the room during cleaning.
9. Dogs may be left free during the day in the agility and running areas under the supervision of their owners. Instead, in the other areas of the Village, they must be kept on a leash and only walk on the paths useful to reach the areas assigned to them (Dog Area, Dog Beach and Dog Solarium).

Dogs are not allowed in the restaurants and bars in the village, in the playgrounds, in the swimming pools (except in the Dog Solarium area of the Oasi pool), in the baby food room and in all other common areas.





It is not allowed to take dogs to flower beds and gardens for their physical needs.

The MareLuna Bar/Restaurant on the beach welcomes your 4-legged friend with pleasure.

10. The owner or keeper of particularly lively or aggressive dogs is obliged to muzzle the dog to ensure the safety of people or other animals.

11. Hygienic bags are available in the Dog House to collect your four-legged friend's droppings and dispose of them in the appropriate containers. One pack per dog can be taken away free of charge.

12. Dog washing can only be done by the staff at the Dog House, while a shower is available at the Dog Beach to remove sand and salt residue.

It is not allowed to wash your dog in the room.

13. Barking and excessively lively behavior by your dog should be avoided in all areas of the holiday

14. The holiday village staff will ensure that the rules are observed, but civil and criminal liability for any damage caused by the dog rests with the owner.

Dog Area

15. Access to the agility and running areas is free. The companion of the dog must be at least 16 years old.

16. It is not allowed to leave the dog unattended.

17. Guests must be careful to avoid damage to the equipment and to keep the areas free of manure, paper or other waste, always maintaining the maximum decency of the structure, as well as ensuring the general hygiene and health of the dogs.

In the Dog Area from 9.30 a.m. to 1.30 p.m. and from 4.30 p.m. to 8.30 p.m. are available for 4-legged guests:

- Dog Parking:

free of charge subject to reservation and availability, in special boxes. This service allows you to take care of your dog for all useful occasions, e.g. Meals, excursions, swimming in the pool etc.

The service is available every day except Thursdays.

-Dog House:





In addition to a collection point for rental equipment (point 7), the Dog House is also a point of sale for dog food and accessories, which can also be supplied according to guests' wishes, as well as a specialist advice centre.

Grooming service from:

- 20.00 euros for dogs up to 10 kg;
- 30.00 euros for dogs up to 20 kg;
- 40.00 euros for dogs over 20 kg.

For stripping or clipping, scissors or machine, the cost will be determined from time to time based on the size of the dog, length of hair and the type of service required.

The Dog House has the same opening times as the Dog Area.

Dog Beach

18. Overlooking the sea, the left side of our equipped beach is dedicated to guests with dogs.

19. The dog must always be kept on a leash up to the promenade, where it can be left free to swim in the water in front of the Dog Beach, so that it does not leave the owner.

20. Dogs in heat, aggressive dogs, too lively dogs or dogs with cardiovascular problems are not allowed on the beach.

21. The dog must be equipped with a collar or harness with identification marks, a leash up to 1.5 m long and a muzzle (to be worn if necessary).

22. The owner must ensure that his dog does not disturb other guests or dogs, does not leave the dog area and always has fresh water and shade available.

23. The following facilities are available at Dog Beach (in addition to those for guests such as umbrellas, loungers, etc.): shower, waste container and dog bed.
